
- Seven Ask Me Anything webinars were conducted in 2023, involving seven NAC members.



Collaboration Committee Participates in Virtual National Conference on Workforce

On May 16, 2023, the Collaboration Committee subgroup (composed of members from NAC, NAPA, ASCE, and SAME) participated in a conference organized by NAPA entitled, "Transforming the Infrastructure Workforce: Takeaways from a Center and National Academy of Construction Infrastructure Workforce Event." (https://federalism.us/2023/07/transforming-the-infrastructure-workforce-takeaways-from-a-center-and-national-academy-of-construction-infrastructure-workforce-event/).

Other organizations that attended that event included Veterans' Employment and Training Service (VETS) in U.S. Department of Labor, American Public Works Association (APWA), Bipartisan Policy Center (BPC), Markle Foundation, National Association of Counties (NACo), National Association of State Workforce Agencies (NASWA), and the National Conference of State Legislatures (NCSL). The conference participants described the existing and emerging programs and initiatives to address the infrastructure workforce.

The Collaboration Committee and NAC members are pursuing future opportunities with collaboration partners, including NAC members on expert advisory committees as workshop/conference speakers and to provide expert testimony. NAC has also discussed with other organizations about collaborating on organizing conference sessions or webinars. NAC is eager to share NAC knowledge materials, including NAC Executive Insights, Ask Me Anything webinars, and the podcasts on "Get the kNACk."

Is Mental Health a Concern in the Construction Industry?

At the 2023 NAC Annual Meeting in Boston, the Academy devoted a significant portion of the business meeting to focus on mental health and suicide prevention in the construction industry.

Many in the design and construction industry do not realize that suicide among construction workers and engineering professionals in the U.S. has reached epidemic proportions. For every worker who dies accidentally on a construction project, five times as many die by suicide. When asked during the Boston business meeting to

characterize this epidemic and pinpoint causes of this unfortunate dilemma, Academy members' responses led to the word cloud displayed on this page.

As a result of the open discussion and the input from attendees in Boston, the Safety Committee will be exploring options for NAC to engage and work toward solutions. Many causes have led to this epidemic. It is not an easy issue to address, but awareness helps. NAC urges everyone in the industry to engage in their organizations and start to resolve this crisis. Also, members may want to engage with the Construction Industry Alliance for Suicide Prevention.

NAC Continues its Work on Safety Culture

Safety culture is defined by NAC as "an all-employee system of shared beliefs, practices, and attitudes in an organization that shape behavior and drive the way in which all work is performed."

After completing the last of five symposia focused on embedding safety culture into undergraduate construction and engineering education programs early in 2023, the NAC Safety Committee continues to expand on this topic. The results of the symposia led to a completed report entitled, Proceedings of the Symposia Series: Introducing and Embedding Safety Culture Concepts in Undergraduate Education. Those interested in the symposia results can find a number of recommendations in this report.



To continue strengthening this effort, NAC has expanded

on the topic of safety culture with a series of Executive Insights, as well as six "Get the kNACk" podcasts (Season 3, Episodes 4, 5, and 23; Season 2, Episodes 5, 6, and 16). Each of these resources are free to the user and provide critical advice concerning how to improve safety and how to build a safety culture both within an organization as well as on construction projects.

The Safety Committee is considering additional university workshops and other means to get the word out to academic and industry leadership. NAC will update all as progress is made.



What Do Many of the Today's Great Construction Leaders Say About Leadership?

Leadership is one of the greatest challenges facing leaders in the design and construction industry at all levels of their organizations. Good leadership is also one of the best force multipliers that an organization can have. NAC has produced a series of podcasts involving many of the most successful leaders in the industry. Thomas F. Gilbane, Jr.

Ted C. Kennedy Award and Medal

Thomas F. Gilbane, Jr., was selected as the 2023 recipient of NAC's Ted C. Kennedy Award and Medal, the Academy's highest honor. He received the award and medal at the Annual Meeting on October 12 in Boston, MA.

Gilbane, chairman and CEO of Gilbane, Inc., since 2009, collaborates with the board of directors in developing strategies for the organization's growth through acquisitions and investments. His "one company" approach emphasizes the corporate resources and expertise on both projects and business decisions. For six years, he chaired the ACE Mentor Program of America, which has the goal of attracting high school students into the architecture, construction, and engineering industry. He currently serves on the ACE executive committee. He is past chair of the Construction Industry Round Table and is a trustee of the Community College of Rhode Island as well as trustee emeritus of Babson College in Wellesley, MA.

Gilbane earned a bachelor of science in business administration from Babson College and a certificate in building construction from the Rhode Island School of Design. He also holds a master's degree in civil engineering from MIT. A graduate of Harvard Graduate School of Business' Advanced Management Program, he served six years in the Army National Guard Engineer Battalion as a 2nd Lieutenant.



James B. Porter, Jr.

Richard L. Tucker Outstanding Service Award

Jim Porter, retired DuPont chief engineer and vice president, engineering and operations, was awarded the Richard L. Tucker Outstanding Service Award in Boston at the Annual Meeting.

The award is presented to an individual whose support of NAC over a sustained period has enabled NAC to grow and prosper. The Academy named the award in honor of Richard L. Tucker, its founder.

Porter was elected as the Academy chair and led NAC and its Executive Committee in 2010. NAC's Construction Forum, a national gathering of industry stakeholders to discuss long-term solutions to workforce and other industry topics, saw Porter serve as co-chair from 2009-2017. He was recognized with the Ted C. Kennedy Award and Medal in 2014. His contributions and active support of the Academy have been continuous over a 20-year span.

For the past seven years, Porter has chaired the Academy's Strategic Planning Committee. He also co-chaired a NAC-IEEE safety workshop along with his wife, NAC member Deb Grubbe, in 2016. A major financial contribution from Porter and Grubbe was their pledged endowment as they became the first members of the NAC Builders Legacy Society. This type of gift is key to the Academy's sustainability and long-term growth. Porter, elected to the Academy in 2003, is currently founder and president of Sustainable Operations Solutions, LLC.

U.S. Army Corps of Engineers Fargo-Moorhead Metropolitan Area Flood Risk Management Project

The U.S. Army Corps of Engineers (USACE) Fargo-Moorhead Metropolitan Area Flood Risk Management Project was selected as the recipient of the Recognition of Special Achievement Award at the Annual Meeting in Boston. The award highlights creativity, innovation, vision, and accomplishments of practitioners in the engineering, design, and construction industries.

The \$3B federal project includes a 30-mile diversion channel with upstream staging and floodwater storage as well as 21 bridges (18 highway, three railroad); two aqueduct structures; nearly 40 miles of levees and floodwalls; three large, gated control structures; 22 miles of dam embankment; four miles of U.S. Interstate-29 raise; and environmental and cultural mitigation and monitoring. The project will provide flood risk management for nearly 260,000 people and 70 square miles of infrastructure in the communities of Fargo, Moorhead, West Fargo, and Horace, ND; and Harwood, MN.

USACE and its partners consistently solved challenges on the project, including simultaneous design and construction. This expedited project will be completed by approximately 10 years when compared to traditional delivery methods. Additionally, it is the first USACE project in the nation to leverage a public-private partnership delivery model.

Joe Albanese is the founder and CEO of Commodore Builders, a construction management/general contracting firm in Waltham, MA. Recipient of the Norman B. Leventhal Award for Infrastructure in recognition of his leadership and the P. Leo Corcoran Humanitarian Award recognizing leadership, philanthropy, and support to those less fortunate.



Minosca Alcantara

Minosca Alcantara is the executive director of the New York State Bridge Authority. Currently serving as a commissioner to the Equal Employment Practices Commission for the City of New York, she designed, implemented, and expanded STEM programs, particularly for women and other underrepresented groups in STEM at the University of Illinois Urbana-Champaign.

Scott Blair serves as editor-in-chief of ENR. ASK ME ANYTHING WEBINAR SERIES KEITH MOLENAAR

The purpose of the Ask Me Anything (AMA) webinar series, led by Keith Molenaar, is to transfer the career knowledge of NAC members to the next generation of construction leaders. NAC members Burcin Becerik-Gerber and Susan Bogus-Halter serve as moderators of the series.

Arizona State University, the University of Florida, and the University of Colorado-Boulder graciously underwrite the series. Through the first 39 AMA webinars, the program has created 2,875 unique connections (each connection can host multiple viewers).

Each webinar features an NAC member who highlights her/his career and then answers questions from the student attendees. Featured NAC members in Spring 2023 (with the theme "CEOs") and Fall 2023 (with the theme "Technology Implementation") included Cheryl Campbell, Wayne Crew, Cheryl McKissack Daniel, John Zachry, Burcu Akinci, Carl Haas, and Lucio Soibelman.

Each webinar provides the opportunity for one participating student to be awarded a \$500 scholarship. To be considered for the scholarship, the student must submit a question to the featured speaker. Scholarships were awarded to students at Clarkson University, Michigan Technological University, the University of New Haven, the University of Florida, Wentworth Institute of Technology, The University of Texas at Austin, and The University of Texas at San Antonio.

Attendee registration for each webinar has consistently grown since the series inception. Over 3,500 registrants currently receive information each month about upcoming Ask Me Anything webinars. Multiple faculty members have used the AMA webinar archive recordings to assign homework and for professional development of university students, with the series charting well over 1,000 archival views in the past year. The AMA webinars are available on the NAC YouTube channel.



AWARDS COMMITTEE HANS VAN WINKLE, CHAIR

The NAC Awards Committee selected and presented the Ted C. Kennedy Award and Medal, the Richard L. Tucker Outstanding Service Award, and the Recognition of Special Achievement Award at the Annual Meeting in Boston. Denise Berger will serve as committee chair for 2024.

The Academy established the Ted C. Kennedy Award and Medal in 2011. The highest honor NAC bestows, it recognizes an individual for outstanding contributions over a career that have immeasurably improved the design and construction industry. Kennedy, the award's namesake, was an Academy charter member. The award criteria is based on his character, and includes a recipient's measure with regard to people, ethics, innovation, education, generosity, and local and national involvement. This year NAC recognized Tom Gilbane, president and CEO of Gilbane Inc., with the award.

The Richard L. Tucker Outstanding Service Award has been presented since 2020 to an individual whose support of NAC over a sustained period has enabled the Academy to grow and prosper. It is named in honor of NAC's founder, Richard Tucker, who personally led the establishment of NAC in 1999. The award recipient is selected by the Academy chair and the CEO/president. Jim Porter, a former NAC chair, a past recipient of the Ted C. Kennedy Award and Medal, and principal author of the Academy's Strategic Plan, was recognized for his many contributions over the last 20 years.

The Recognition of Special Achievement Award, in its second year, selected the St. Paul District of the U. S. Army Corps of Engineers for the outstanding accomplishments in the Fargo-Moorhead Metropolitan Area Flood Risk Management Project. The Academy presents the award to highlight the creativity, innovation, vision, and accomplishments of practitioners in the engineering, design, and construction industries. The award demonstrates NAC's commitment to build and grow broad public knowledge and support for special project achievements and their effects on the built environment and safety.



COLLABORATION COMMITTEE SARAH SLAUGHTER, CHAIR

During 2022-2023, the Collaboration Committee established a collaboration subgroup with the National Academy of Public Administration (NAPA), the American Society of Civil Engineers (ASCE), and the Society of American Military Engineers (SAME). The subgroup met several times to discuss national issues as potential collaboration topics, including infrastructure, project delivery, and workforce. In May, that subgroup participated in a conference arranged by NAPA that focused on transforming the infrastructure workforce. NAC members, through its efforts with the Board on Infrastructure and the Constructed Environment (BICE) in the National Academy of Science, Engineering, and Medicine (NASEM), agreed to participate in NASEM committees or studies and to contribute to NAPA committees.

To date, the Collaboration Committee has authored five Memorandum of Understanding (MOU) agreements that outline roles and responsibilities of collaboration partners. The MOUs have all been approved by the NAC Executive Committee and mutually signed by the parties. The most recent MOUs are with the Society of American Military Engineers (SAME) and the Chartered Institute of Building (CIOB) in the UK. The previous MOUs have been signed with BICE, NAPA, and ASCE.

The Collaboration Committee recognizes the excellent work and leadership by Pete Marshall in leading the NAPA-NAC collaboration, Mike Loose in the ASCE-NAC collaboration, Mark Handley with SAME-NAC Collaboration, Richard Anderson with CIOB-NAC, and Edd Gibson with NAE-BICE.



COMMUNICATION & MARKETING COMMITTEE

SANDY HAMBY, CHAIR

NAC reorganized and refocused its communication and marketing activities in 2023. Committee Chair Sandy Hamby led the work of the committee, assisted by Palmina Whelan, vice chair. Working with NAC staff, the committee leadership added three new members.

The committee created a long-term communication plan and budget to maximize NAC thought leadership via multiple media and communication methods. The plan will be in line with the 2023 Strategic Plan. The committee also worked with NAC staff to better leverage LinkedIn® as an external communication mechanism. Coordinating with the Development Committee, a plan was established to communicate the 2023 Fund Raiser to members and potential sponsors. The committee also wrote and distributed a joint press release with the U.S. Army Corps of Engineers (USACE) public affairs office for NAC's Recognition of Special Achievement Award that honored the USACE Fargo Area Flood Risk Management Project.

Other NAC committees identified the Communication and Marketing Committee as the committee needed most for collaboration due to the need to publicize efforts, internally and externally. For 2024, a long-term communication plan will be developed along with a communication and marketing budget. The committee is considering the adoption of an internal communication software platform to enhance membership participation. The committee plans to vigorously support the publicity around the 25th anniversary of NAC.





DEVELOPMENT COMMITTEE GRETCHEN GAGEL, CHAIR

NAC reorganized and refocused its development activities in 2023. The Development Committee was led by Gretchen Gagel, chair, and Maggi Walker, vice chair. The committee's activities in 2023 and the future all tie to the new Strategic Plan.

Working with NAC staff, the committee established two subcommittees, "Askers" and a second subcommittee that focused on the Annual Auction. It also developed a clearer view of the Academy's sources and uses of funds. This allowed the committee to develop annual fundraising goals and establish a list of potential industry supporters. A fundraising timeline was formulated as well as training for the Askers subcommittee.

The committee's annual fundraising campaign in 2023 was successful, as industry giving for 2023 was up nearly 20 percent and individual giving increased over 75 percent compared to 2022. The year ended with \$121,000 in industry gifts pre-pledged for 2024, an increase of over 50 percent from 2023. The Annual Auction results came in as the second highest net intake in NAC history. Direct support also came from University of Colorado-Boulder, Arizona State University, and the University of Florida as sponsors of the Ask Me Anything webinar program for 2023-24. In addition, \$35,000 was raised to support sponsorship for the Annual Meeting in Boston.

For 2024, the committee will be again seeking outside sponsors to support NAC programs as well as to support the Academy's 25th Anniversary celebration in San Antonio in October. Also, committee work will include implementing a Customer Relationship Management (CRM) system to support fundraising activities. In addition, the committee will work to provide a better focus on the Builder's Legacy Society, the Academy's planned giving program. All funds contributed to the Society will build the Academy's permanent endowment and help ensure that Society members are honored in perpetuity.





ENDOWMENT FUND INVESTMENT COMMITTEE

RICH SCHRADER, CHAIR

During 2023, the Endowment Fund Investment Committee welcomed two new committee members, Cheryl Campbell and Steve Thomas. The committee thanks JJ Suarez for his service and contribution as he departs. Steve Thomas will assume the position of vice chair in 2024. Rich Schrader will continue as committee chair. The committee has been working diligently with the Executive Committee and Merrill Lynch on updating the Fund Investment and Operating Policy Statement and hopes to have all input finalized for a completed document by calendar year end 2024.

The committee is also working with Merrill Lynch to adjust the self-managed part of the NAC portfolio as appropriate, maintaining a posture of moderate risk combined with future growth potential. The committee reaffirmed the resultant asset mix as being aligned with current NAC strategic goals.

EXECUTIVE INSIGHTS

JERRY EYINK, CHAIR

The Executive Insights Program captures the knowledge, experience, and wisdom gained through individual NAC members in their leadership roles in the construction industry. Anna Franz and Sue Steele serve as vice chairs of the committee.

The committee and NAC staff created a searchable heading on the NAC web page, NAC Knowledge, which is the collection of Executive Insights and Get the kNACk podcasts.

The Executive Insights Program execution plan for 2023 focused on three main areas:

- 1. Quality content that is relevant. The total number of Executive Insights and released podcasts was 208 at year's end.
- 2. Expand the authors of NAC Knowledge. To date, 64 NAC members have shared their wisdom by being Executive Insights authors or Get The kNACk podcast guests.
- 3. Expand NAC Knowledge distribution. NAC Knowledge needs to be shared with NAC's collaboration partners, the academic community, and industry organizations. Members can also share through their personal networks and organizations.

Two key podcast metrics indicate the momentum that the Executive Insights Program is providing:

- 76 percent growth for 2023 compared to 2022.
- Downloads outside the U.S. 10 percent of downloads occur in Europe and three percent in Asia, while 80 percent occur in North America.

In 2024, a new special Get The kNACk podcast series will be introduced, "Leadership in Construction—Wisdoms From NAC Masters." New NAC members are challenged to share one key insight that helped drive their career success. NAC COMMITTEE REPORTS



FINANCE COMMITTEE SAM SLEIMAN, CHAIR

The calendar year (CY) 2022 audited financial statements are included at the end of this annual report. The complete audit report can be obtained by contacting the NAC office. For CY 2022, Total Revenues were just over \$817,000 while Total Expenses totaled \$952,000 for a net loss of \$134,000. Total assets decreased by almost \$310,000 driven largely by losses in NAC's investment accounts as well as the net operating loss for the year. The three-year average for sources and uses of funds is given below.

CY 2023 was much more robust than 2022. The introduction of a new development plan/activities, focus on strategic planning, strong leadership for the Annual Meeting in Boston, increased focus on communication and marketing, and stronger economy were positive influences on growth in CY 2023. The appointment of a new full-time President/CEO brought added salary expenses for the year (the previous President/CEO was half-time), but also brought more time and new energy toward fundraising and programs. Contributions from the NAC membership in 2023 far exceeded the previous year and investments rebounded with an increase of \$165,700, which resulted in an unaudited year-end net income of \$116,600.

NAC COMMITTEE REPORTS



MEMBERSHIP COMMITTEE KEITH MOLENAAR, CHAIR

The Academy inducted 34 new members into NAC at the 2023 NAC Annual Meeting on October 12 in Boston. Maintaining the rigorous process to ensure that only the "best of the best" are inducted, membership to the Academy begins when a current member submits a prospect for consideration or a nomination to the membership committee. Following a thorough review and vetting, including solicitation of comments from all Academy members, initially at the subgroup level, the NAC Membership Committee then selects final candidates for the annual ballot. The election is made by the general membership.

Special thanks go to Membership Committee chair, Keith Molenaar, and vice chair, Bill Seed, and especially subgroup leaders Randall Iwasaki, Manish Kothari, Christine Merdon, Walt Wise, and Sam Ariaratnam for the committee's thoughtful and complete candidate analysis. Their work with staff simplified and improved the nomination process and led the Academy's prospects into the election process.

It is the obligation of each Academy member to participate in the identification of potential new members. A member recommending a prospect to the Academy will provide, at a minimum, the reason(s) the prospect should be considered for membership and a two-page resumé. Prospects are then considered by the Membership Committee's five subgroups: Owners; Designers/Architects/Engineers; Contractors/Construction Managers; Services (consultants, labor, attorneys); and Academics/Researchers.

Subgroups use the submitted information initially to rank prospects. Nomination packages are then secured for the top prospects along with comments from the general membership. With the official nomination, references, and comments, the subgroups then complete final rankings. Generally, the top five ranked prospects in each subgroup are moved to the ballot. The remaining slots on the ballot are filled by agreement among the full Membership Committee.

As stated in the NAC By-laws, Section 3.6, membership qualifications are:

- Industry leaders whose present or past professional careers over a period of years have demonstrated outstanding contributions to the effectiveness of the industry.
- A demonstration of high personal integrity and wide recognition of the person's work by their industry peers.
- Achievements may be in productivity, technology, academic excellence, safety, executive leadership, working relationships, communications, labor relations, and other industry areas.





SAFETY COMMITTEE KEN ARNOLD, CHAIR

The Safety Committee continued the Safety Symposia series. It also collaborated with the National Academies of Science, Engineering, and Medicine's Board of Infrastructure and the Constructed Environment (BICE) as well as the Executive Insights Committee. In 2024, Tony Leketa will take over as committee chair and Charles Bacon will serve as vice chair.


The Safety Committee symposia series during 2023 was conducted with six universities to explore industry and academia perspectives on safety cultures. The universities involved included the University of Kansas, Worcester Polytechnic Institute, New Jersey Institute of Technology, The University of Texas at Austin in conjunction with Texas A&M University, and the University of Colorado-Boulder. The single-day series held at the universities drew representatives from 45 universities and 94 construction companies. ENR covered the symposia with two articles in 2023.

The committee worked with BICE on safety culture concepts. The information from the NAC Safety Symposia series will serve as input to BICE in that group's work in the same area of safety culture.

The committee began publishing a series of Executive Insights in a new Safety Culture Series. Executive Insights published in the series include:

- Human Performance Principles
- Worker Participation in the Safety Management System
- Incident/Accident/Near-Miss Reporting and Investigations
- Drug and Alcohol Testing
- Training

The committee has had discussions and distributed information on the need for helmets and has started a subcommittee on mental health.




SCHOLARSHIP COMMITTEE ADJO AMEKUDZI-KENNEDY, CHAIR

The generosity of NAC's members is making a difference in students' lives as they graduate and proceed into a career in the construction industry. In 2023, 18 members of the Scholarship Committee continued to refine the application and selection process for awarding NAC scholarships. The committee identified an outstanding cohort of seven NAC scholarship awardees, including the inaugural Wayne A. Crew Scholarship awardee, for the 2023-24 academic year. This year's NAC Scholars were particularly well rounded and received awards totaling \$35K. Six of the seven recipients attended the NAC Annual Meeting in October in Boston, MA.

The committee also worked with the ACE Mentor Program to select and administer \$35K in scholarship funding to students actively involved in ACE. The Academy made a generous donation to the ACE Mentor Program from funds generated by the NAC 2022 Auction. Seven additional 2023 NAC-ACE scholarship recipients were selected to receive this funding.

Many thanks to the members of the Scholarship Committee for their outstanding levels of engagement and their commitment to identifying and mentoring future leaders in the construction industry. Michael Garvin will take on the leadership of the committee and Andy Ciancia will serve as vice chair in the 2023-2024 academic year. With more applications from scholarship candidates being submitted each year, the Scholarship Committee plans on adding Academy members to help with the program as interest in NAC scholarships grows.





STRATEGIC PLANNING COMMITTEE JIM PORTER, CHAIR

NAC reconstituted the Strategic Planning Committee in 2023, with Jim Porter as chair and Pat Natale as vice chair. The committee's charter was to review the current Strategic Plan, last published in 2017, and then update that document to establish a new five-year plan for the Academy. The committee was also tasked with establishing a list of key performance indicators that tie to the Strategic Plan with an eye on the sustainability of the Academy.

The committee met in February and proceeded with developing, distributing, and analyzing a questionnaire, which it presented to the NAC membership for input regarding the Academy's strategic direction. That activity led to a first draft of the new plan and a review with the Executive Committee. In conjunction with that Ex Comm review, the committee analyzed plans from similar associations. In addition, advice from individuals not part of NAC was also gathered. Taking this collective input, the committee further revised the Strategic Plan and held a series of Zoom meetings with membership to review once again. The committee then presented a final revised Strategic Plan for a vote by the NAC membership at the September Virtual Business Meeting. The membership unanimously accepted the revised plan.

The committee is now in the process of using the new Strategic Plan to establish a tactical plan for 2024, including metrics. It plans to monitor this plan for results in 2024. Thanks to all who participated in this plan development. The high-level Strategic Plan is shared on the next two pages.




